# Budget

Grants of up to \$15,000 will be awarded.

Funding may not be applied to expenses incurred before July 1, 2025.

Grant activities must be completed by June 30, 2026.

Applicants are required to submit a budget for the proposed project, listing anticipated expenses and any revenue.

Grants will cover up to 100 percent of eligible expenses, not exceeding the amount of the grant award; no matching funds are required. Additional expenses to complete the project are the responsibility of the creators.

Eligible expenses include but are not limited to:

- O Vocalist, instrumentalist, and other performer fees;
- o Music director/conductor;
- o Dramaturg;
- o Orchestrator, arranger, copyist;
- o Stage director;
- o Vocal coach;
- o Sound designer;
- o Rehearsal and workshop venue rental fees;
- o Stage manager;
- o Equipment rental (e.g., lighting, sound, instrumental cartage);
- o Childcare and/or eldercare while creators are in rehearsal or workshop;
- O Research materials (e.g., performance tickets, new work recordings, reference books);
- O Living expenses for the composer of up the 30% of grant request; and
- O Transportation and housing for personnel related to creative meetings, rehearsals, and performances. (Airfare is limited to coach class.)

You may wish to include ineligible expenses on your budget in order to give panelists a more complete picture of your planned activities and/or process. This is optional; note that this may require you to show other sources of support beyond the Discovery Grant (prospective or secured).

- o Ineligible expenses include:
  - o Commissioning fees to composers and librettists;
  - Set, costume, or properties construction or rental expenses for a fully staged production;
  - O Institutional overhead expenses if partnering with an organization;
  - O Expenses that are not connected specifically to a project, including general administrative expenses and competition or contest application fees;

Below is a sample budget breakdown for a potential project funding a piano workshop. This is just one proposed model for your consideration. No item contains a standardized rate because there are not any. The best suggestion for a budget layout is to take the budget you have available, start with the highest responsibilities/fees, and work down from there.

5-Day Workshop for New Opera Based on a Budget of \$14,000 Piano workshop in NYC. No travel or housing costs required.
5 days workshop with public/invited event on last day

6 hours per day (2x3 hour session; i.e., 10-1 and 2-5 with one-hour break)

\$2000 - Conductor/Music Director (1 person)

\$2000 - Stage Director

\$1500 - Piano/Coach (1 person)

\$1250 - Dramaturg

\$1250 - Stage Manager

\$3750 - 3 Singers - principal roles (\$1250 each)

\$2250 - 3 Singers - secondary/ensemble roles (\$750 each)

# Work Samples

### **Composer Samples**

Applicants are required to submit two work samples that best represent their voices and creative styles. The most competitive applications will include examples of recent compositions that demonstrate the composer's ability to compose theatrical works for the trained voice and instrumental ensemble. Work samples need not be classical or operatic.

Samples that demonstrate the creator's aptitude for theatrical storytelling are recommended. At least one sample must feature voice(s) (not digitally generated).

All samples should be hosted audio or video on sites like YouTube, Vimeo, Dropbox, or SoundCloud. Combined samples must be no longer than 20 minutes. Neither sample should exceed 10 minutes in length. It is the applicant's responsibility to ensure samples are accessible to the review panel until they are notified of the outcome of their application.

Applicants are strongly encouraged to submit excerpts of the work for which funds are being requested, if possible. If work samples from the proposed work are not available, be prepared to explain how the submitted sample(s) are stylistically related to the proposed work.

Scores or other forms of visual representation of a musical work are optional.
